Taylor was a chaplain at St. Paul's Chapel at the World Trade Center site. Rev. Taylor serves on the Hudson Valley Critical Incident Stress Management Team and the Unitarian Universalist Trauma Response Team.

**Peter Volkmann, MSW** graduated with a Bachelor of Science in Criminal Justice from Mercy College and received his Masters in Social Work from Fordham University. Peter is the east coast liaison coordinator and a representative to the United Nations for the ICISF Peter is also the state coordinator for the CISM network of New York State. Because of his vast experience in the different rescue fields and the social work profession, Peter is utilized as a crisis interventionist and trainer for rescue departments, government municipalities, schools, and corporate organizations around the United States.
